Comprehensive Patient Scheduling

Maximize OR time and streamline physician offices booking processes

By combining advanced multifacility features with flexible scheduling tools, ORM maximizes operating room time and helps increase the accuracy and stability of schedules, promoting better utilization of resources. Benefit from the ability to grant physician offices remote access for convenient direct scheduling expedites and assists with accuracy for processing of requests.

Physician Office Link

Bridge the communication gap while reducing phone calls and paperwork by empowering physician's offices with **Physician Office Link**. This component of ORM provides the capability for physician offices to 'reserve' a surgical appointment directly in ORM. This reservation process is most often used by facilities that utilize assigned block times. The requested time is placed on the schedule by the physician's office as a 'reserve' until the booking agent at your facility either confirms or rejects the requested appointment. Surgeon's offices can 'reserve' in their block of time, as well as 'request' out of block time.

Preference Cards / Supply Chain Management

Track supplies, simplify billing/inventory control and significantly reduce waste.

With ORM, facilities can quickly track supplies, update preference cards and transmit data to a materials management system, where this information automatically decrements inventory and triggers reorders. Calculate supply and non-supply costs then transmit patient charges to billing upon verification.

Materials Management Interface

One of the most compelling interfaces of ORM is the materials management interface. It controls the inventory and manages the decrementing and incrementing of inventory for the facility. A large share of waste is due to lack of inventory control, however with bidirectional interfaces with ORM, facilities can accurately charge the patient or reconcile their costs.

Tissue and Implant Management

Tissue tracking

OR Manager tracks receipt of tissue as well as preparation information including solution and antibiotic administration. Packaging integrity is documented while a bidirectional tissue management interface is supported for 3rdparty solutions. Easily access all vital data points to identify when the tissue was received, where it was stored, when and how it was transported, etc. if questions, concerns or future incidents arise.

Implant tracking

Electronic systems are only as good as the data they are collecting. When it comes to implants, the ability to track, manage and report is key. In the event of a recall, you can quickly and effortlessly find the patients you need to contact. If there is a question of inventory control, the facility can quickly find out where inventory is located, as well as if and where it was used.
